Rental Guidelines

Permit and/or alcohol/noise/traffic waiver must be on site day of event to avoid conflicts/questions.
 No alcoholic beverages allowed without Municipal waiver from Parks and Recreation.
 User group responsible for cleanup of all trash/litter/garbage from permitted areas.
 Each policy of insurance required by this section shall provide for a faxed copy of insured's cancellation notice, within two(2) business days of receipt, to the Municipality of Anchorage, Parks and Recreation Contracts Administrator.
 User group aware of refund or transfer policy. Cancellations and refund request must be received 14 days prior in writing to be eligible for full refund.
 There is no guarantee that portable toilets are on site. Portables that are on site are on predetermined servicing schedule. Please consider calling Rent-A-Can @ 694-9202 to rent a portable specifically for your rental event, or consider contracting with Rent-A-Can to service portable on site just prior to your rental event. Rates apply. Please make arrangements with RAC a minimum of 7 days prior to your rental date.
 No open fires or burning. BBQ grills permitted with proper supervision at all times.
 Revisions to this permit requires 72 hours notice, and a \$50 processing fee.
 Permitted party responsible to enforce permitted areas - Failure to do so is not grounds for refund.
 Use of fireworks and firearms of any type are not allowed in the Parks.
 User group must set up and clean up within rental time stated on permit.
 Emergencies may constitute a refund.
 Proper supervision at all times.
 Use approved as described in letter of intent.
 Park/Facility/Playground/Parking lot will remain open to the public.
 No driving or parking on grass.
 User responsible for any damages that might occur during event to building or grounds as a result of their rental.
 The MOA reserves the right to cancel this permit at any time for any reason.
 Parking may be limited. Carpools or shuttles may be necessary.
 If trash is not disposed of and/or removed properly from premises, the customer shall be billed \$100.00 per hour for cleanup of area and trash removal. This shall include dumpster overflow. Absolutely no trash bags or trash of any sort may be left on grounds, including around dumpster area.
 The permit holder shall indemnify, save harmless and defend the Municipality of Anchorage, its officers, agents and employees from liability of any nature or kind, including cost and expenses, for or on account of any and all legal actions or claims of any character whatsoever resulting from injuries or damages sustained by any person or persons or property as a result of any error, omission or negligent act of the permittee relating to the use of the facility/park.
 Permittee shall assume and reimburse the Parks & Recreation Department for any and all costs and expenses including labor, for damages to the facility or park land, including flowers, trees, shrubs, and staging area that have occurred from this event.
 There are no First Aid stations on site. Highly recommend that Permittee make arrangements for First Aid be on site for attendees of rental.
 Insurance is required. List the MOA as additional insured for general liability: Municipality of Anchorage 632 W 6th Avenue, Suite 630 Anchorage AK 99501
 No disturbing nesting areas or feeding, chasing, or harassing the bird life.
 User is responsible for spectators and players.
 'Bear Activity' User Groups are Required to REMOVE ALL TRASH from park.
 Financial Responsibility: Failure to notify Parks and Recreation of cancellation will not relieve applicant of the financial responsibility established by the request. Failure to pick up the park permit or to cancel the reservation will result in the permittee being billed for the price of the permit.
 Refunds may be granted per the following time scale provided there is justification. A written request for the refund must be submitted with proof of payment. Refund requests will take between three and six weeks to process. Cancellation Notice to P&R Prior to two weeks, 100% refund: 7-13 days before event, 75% refund: 3-6 days before event, 50% refund: 1-2 days before event 25% refund: Day of event 0% refund
 Noise Permit: Anchorage Health Department issues Noise Permits for events open to the general public, which can allow a temporary increase in allowable noise levels. Private events are not eligible for a Noise Permit. Noise permit applications must be filed with the Health Department at least twenty (20) days prior to the commencement of the noise for which the permit is requested.
 Noise Permit: If a Noise Permit is not present, noise from the event may not exceed 60 dBA (normal voice conversation) at any residential property line between the hours of 7:00 a.m. and 10:00 p.m., and may not exceed 50 dBA at any residential property line between the hours of 10:00 p.m. and 7:00 a.m.
 The Permittee shall acknowledge, in a positive manner, the Municipality of Anchorage Parks & Recreation Department in its film credits. Permittee shall not print or air derogatory information/statements about the Municipality of Anchorage.
